REQUIREMENTS FOR REGISTERING AN ELECTRICAL LICENSE

AN ELECTRICIAN MAKING APPLICATION TO REGISTER THEIR ELECTRICAL LICENSE WITH THE CITY OF DEER PARK MUST COMPLETE AN APPLICATION FORM.

NEW APPLICANTS

REGISTRATION FOR A NEW MASTER ELECTRICIAN IS A SEPARATE APPLICATION FORM.

NEW APPRENTICE ELECTRICIAN CERTIFICATE APPLICATION MUST INCLUDE:

1. Copy of applicant's current State issued license
2. Two 2 x 2-1/2" colored photos on color photo paper
3. Notarized letter on company letterhead specifying you the apprentice are employed by the company with name of the master also given.

NEW JOURNEYMAN ELECTRICIAN CERTIFICATE APPLICATION MUST INCLUDE:

1. Copy of applicant's current State issued license
2. Two 2 x 2-1/2" colored photos on color photo paper
3. Notarized letter on company letterhead specifying you the journeyman are employed by the company with name of the master also given.

RENEWAL APPLICANTS

As long as an electrician (apprentice, journeyman, and master (active & retired) continues employment with the same company from one year to the next, their registration may be renewed on a continuing basis.

RENEWAL APPLICATION OF AN APPRENTICE ELECTRICIAN CERTIFICATE MUST INCLUDE:

1. Copy of applicant's current State issued license

RENEWAL APPLICATION OF A JOURNEYMAN ELECTRICIAN CERTIFICATE MUST INCLUDE:

1. Copy of applicant's current State issued license

RENEWAL APPLICATION OF A MASTER ELECTRICIAN CERTIFICATE MUST INCLUDE:

1. Copy of the applicant's current State issued license
2. Copy of the Company's current State Contractor license
3. Copy of current Certificate of Insurance

All applications must be signed by the company owner and the applicant's signature must be notarized.

Should an electrician change employment from one year to the next and wish to register with the City of Deer Park, they are considered to be a new applicant and must follow the new applicant process of pictures, letters, etc. along with the application form.

TERM OF REGISTRATION

The registration period for registering an electrical license with the City of Deer Park is on a calendar year. The State of Texas issues license with various expiration dates. It will be the responsibility of the license holder to provide the City of Deer Park with their current electrical license.

Should an electrician's license or a company's insurance expire, the company will be placed on hold and be unable to pull permits until proof of current insurance and state license is provided.
