Insurance Requirements

ELECTRICIANS

(a) No permit shall be issued until the master electrician or his employer shall have arranged to carry the following insurance:

(1) Worker's compensation insurance on *each* and *every* employee. This insurance shall be in accordance with the provisions of the Worker's Compensation Act of the State of Texas (Vernon's Ann. Civ. St. art 8306 et seq.), and;

Public liability insurance to the extent of fifty thousand dollars (\$50,000) for any one (1) accident and one hundred thousand dollars (\$100,000) for any one (1) person, and;

Property damage insurance to the extent of ten thousand dollars (\$10,000) for any one (1) accident and one hundred thousand dollars (\$100,000) in the aggregate.

(b) Such insurance shall be written by an accredited company under the supervision of the board of Insurance commissioners of the State of Texas.

(c) Evidence of compliance with the above insurance requirements shall be considered as having been met when the policy, a copy thereof, or a certificate of insurance has been filed with and approved by the Electrical Board will be notified at least ten (10) days in advance in the event of the policy or policies being canceled or expiring before the expiration date of the license. SELF EMPLOYED ELECTRICAL CONTRACTORS/MASTERS

Any State licensed master or contractor electrician who is self employed with no employees must sign an Affidavit of Self Employment and will not be required to provide Workman's Compensation Insurance.

PLUMBING & MECHANICAL CONTRACTORS

The City of Deer Park shall not register a master plumber or mechanical contractor until and unless the contractor furnishes proof of comprehensive general liability insurance (including products liability and completed operations coverage) with minimum limits of \$300,000 for death or bodily injury and \$300,000 for property damage, per occurrence. The policy must be issued by a carrier that is listed with a rating of A or A+ in the last published edition of Best's Insurance Reports - Property Casualty Volume (published by A. M. Best Company, Oldwich, NJ 08858). It shall be the duty of each registered contractor to maintain current proof of coverage with the City of Deer Park. The proof of coverage shall be provided in the form of a certificate issued by an authorized agent or employee of the company issuing the policy that specifies the coverage and identifies the insured.
