


V.I.P.A.R. Program

Dear Potential V.I.P.A.R. Parents/Guardians and Participants,

Thank you for considering volunteering in the City of Deer Park V.I.P.A.R. program. We are excited for our 23rd summer to start!

If you are new to the program, you are probably wondering, what is V.I.P.A.R.? V.I.P.A.R. stands for Volunteer in Parks and Recreation and was created in 1996 to teach this age group about the importance and aspects of a job from filling out an application, to interviewing and being responsible for a work schedule. It exposes the youth to new skills while providing extra help for the department. Our program provides volunteer opportunities for youth during the summer. Boys and girls can volunteer while having fun at Camp Crabgrass, Movies and Concerts in the Park and other youth geared camps as well as participate in art programs. The program gives kids a chance to practice life skills and learn responsibility, preparation and accountability.

What are we looking for? We are looking for energetic teens ages 12-15 to volunteer with us in the summer who are able to meet the following requirements:

- 12-15 years old
- Responsible and a great attitude towards volunteering
- Respectful towards all employees, adults and participants
- Good communication
- Get to work each day and perform all duties required
- Must have reliable transportation (adult driving you, walk, bike, etc.)

If you are interested in this program, fill out the attached application and return it to the Deer Park Community Center or email it directly to Stephen Bibbs no later than June 6th.

What happens once you apply? Once we reach our deadline, we contact all of the participants by email and home telephone number. We will set up an interview time to come in and meet with us. After the interview, we will send you an acceptance or a “maybe next year” letter. Many variables go into choosing a V.I.P.A.R., this includes availability, interview and how many available spots we have for the summer.

Summer will be here before we know it and we are looking forward to working with you and your child. If selected to be a summer 2020 V.I.P.A.R., we will give you further information about what to expect in the summer.

I certify that I have no medical or physical conditions, which would interfere with my safety in this activity, or else I am willing to assume, and bear the costs of, all risks that may be created directly or indirectly by any such condition.

I agree that the laws of the State of Texas apply and venue shall be in Harris County, Texas regarding any issue that may arise in any way connected with this agreement, acknowledgment of risk, release and indemnity.

I understand that public relations are an important part of volunteering with the City of Deer Park.
